  - (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order") which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies; and
  - (c) the joint statement by the Accounting and Corporate Regulatory Authority, Monetary Authority of Singapore and Singapore Exchange Regulation of 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020 and 1 October 2020) which provides additional guidance on the conduct of general meetings during the period from 1 October 2020 to 30 June 2021.
- 2. **Date, time and conduct of Annual General Meeting.** The Company is pleased to announce that pursuant to the Order, its 42<sup>nd</sup> AGM will be convened and held by way of electronic means on **Monday, 23 November 2020 at 9.30 a.m.**
